Aadil Bashir, Unjum Bashir, Afifa Lone & Afnan Tariq examine the role of skill development initiatives and its impact on the growing unemployment in the state of Jammu and Kashmir (J&K), India.

Farzana Gulzar & Aiman Fayaz present an evaluative review of entrepreneurship opportunities in J&K (India) industries. The paper explores various industries of J&K and highlights employment opportunities in these industries. The study addresses the need for nurturing entrepreneurs to tackle the rising problems of unemployment in Jammu and Kashmir, thereby boosting the economy of the State.

Manzoor Hussain & Gousia Yaseen discuss the rural housing and accommodation phenomenon stressing on Indira Awaas Yojana (IAY) scheme in Kashmir.
